### Potential School-Based Services for Children with ADD/ADHD

Parents who call the WI FACETS help desk often think that because their child has been diagnosed with Attention Deficit Disorder (ADD) or Attention Deficit Hyperactivity Disorder (ADHD) by the medical community that the child automatically qualifies for special education services. A medical diagnosis of ADD/ADHD does not automatically qualify a child for special education services. As excerpted from the Wisconsin Department of Instruction website (WI DPI), "Attention Deficit Disorder" (ADD) and "Attention Deficit Hyperactivity Disorder" (ADHD) are conditions outlined in the federal definition of Other Health Impairment 34 C.F.R. § 300.8(c)(9) as examples that may qualify a student as having an Other Health Impairment (OHI). ADD or ADHD may also be a condition associated with other disability category criteria.

The Special Education Eligibility Criteria and Evaluation for Other Health Impairment (OHI) developed by the WI DPI highlights two factors that must be present for the child to qualify for special education under the OHI category.

Training for Home Language Interpreters: Supporting Families through the Special Education Process

For those seeking training for home language interpreters for families at IEP meetings, Wisconsin DPI has partnered with WI FACETS, LEAs, and other organizations to develop a one-day training for home language interpreters who interpret for families at IEP meetings. Language interpretation training is a requirement to meet the provisions outlined in Wisconsin's DPI's Providing Language Assistance to Parents guidance document. The training provides increased awareness of state and federal laws, regulations and policies related to the educational rights of students who receive special education through an IEP and who may also be English Language Learners. The training also provides increased knowledge of legal responsibilities and requirements related to translation and interpretation of special education terms and concepts, tools, and resources for interpreters. Finally, the training supports improved skills to handle common ethical considerations while interpreting IEP meetings.

### Expect, Engage, and Empower: Successful Transitions for All!

One of the missions of Miguel Cardona, Secretary of Education, is to improve equity across our nation's schools. In support of that mission, the Director of the Office of Special Education Programs (OSEP) Valerie Williams has announced a new initiative to improve postsecondary outcomes for students with disabilities — *Expect, Engage, and Empower: Successful Transitions for All!* 

This initiative will challenge the field to join OSEP to raise expectations, engage families earlier, and empower all who support transition services to measurably and significantly improve postsecondary outcomes for children and youth with disabilities and their families. Every family that has an infant, child, or youth identified with a disability must be exposed to high expectations from day one. According to Williams, three things must happen in order for improvement to occur.

- The education and vocational rehabilitation systems must work together.
- Critical discussions about the future and transition planning process must start sooner, and
- ALL students with disabilities should have the opportunity to learn about all post-secondary opportunities and make the best choice for themselves.

### **Center for Parent Information and Resources (CPIR)**

### Wisconsin Department of Public Instruction (WI DPI)

This website has information on how a child with ADHD may qualify for special education services under "Other Health Impaired" (OHI). It also includes <u>links</u> to several online resources related to identifying students with ADHD and programming to support them.

#### Children and Adults with Attention-Deficit/Hyperactivity Disorder (CHADD)

CHADD is a national non-profit organization providing education, advocacy, and support for individuals with ADHD. ### <u>Understood</u>

Understood is a nonprofit dedicated to shaping the world for difference. They provide resources and support so people who learn and think differently can thrive — in school, at work, and throughout life. The goal of this website is to empower parents to understand their children's learning and attention issues and relate to their experiences. With this knowledge, parents can make more effective choices for and with their children. The site also has some great suggestions for students such as <u>5 self-advocacy sentence starters for middle schoolers with ADHD</u>.

### <u>ADDitude Magazine</u>

The website provides practical information about raising children with ADHD, including behavior and discipline strategies, helping in making and keeping friends, and organizing for success. There are a multitude of education and learning resources to help students (and the teachers who work with them) succeed at

school. While the website also includes the option of a paid subscription to the magazine, most of the articles are free and accessible.

# The Effects of Automated Prompting and Self-Monitoring on Homework Completion for a Student with Attention Deficit Hyperactivity Disorder

### **Read Full Article**

This study examined the effects of an intervention consisting of automated prompting and self-monitoring on the level of independent homework task completion for an elementary-age student with attention deficit hyperactivity disorder (ADHD). Instituting a single subject, within series ABAB design, (ABAB design is defined within article) the results showed a consistent increase and stability in homework task completion following the introduction of a vibrating alarm wristwatch and a self-monitoring homework routine checklist. Stable homework performance continued through the 5-month follow-up, as well as following a termination and change in medications which occurred during month two and three of the follow-up phase. Additionally, academic performance as measured by mathematics and language arts school term grades showed improvement. Results are discussed considering parents as active co-problem-solvers, the role of applied behavioral action research, and the efficacy of self-management with students with ADHD.
